### **Skyhawks Meeting Minutes**

### April 2, 2023

The meeting was held at the Hiawatha Library. It was called to order shortly after 7:00 p.m. by Todd Davis. There were 12 members in attendance.

Jim Doty gave the Treasurer's Report. We currently have 50 members paid for 2023 season. The Port-O-Potty will be ordered this month.

Secretary's Report for March meeting was read by David Logan.

#### **Old Business**

#### • Fross Park Event

The Fross Park event in Center Point will be held. We are checking to see if there are some members who might want to do static displays. It was determined that the site won't allow for flying large scale aircraft due to power lines in the vicinity. Wendell said he would talk to Jim Newman about bringing the Curtiss Jenny that Jim Stickley had built. The event is May 21.

#### • Airfield Notes

The parking area for the airfield has been torn up badly due to people driving on it while it was wet and soft. Please make sure the parking area is dry and hard before driving on it. Possibly consider walking equipment in if you want to fly early season. Also, if the parking area is soft, there is a good chance the runway is also too soft and wet to fly on and off of and especially to be walking on it. Please refrain from using the runway if it is soft.

We need to get more gravel on the driveway. The club will make contact with the city to see if they might be able to help us get some more gravel down.

#### Donated Planes

The planes that were donated have been auctioned.

- You must pass the recreational UAS test.
- Todd discussed this final requirement. You may visit the Pilot Institute website at <a href="https://trust.pilotinstitute.com/login/signup.php">https://trust.pilotinstitute.com/login/signup.php</a> to register and take the TRUST test. It is free and will take about 30 minutes to complete. You will want to print your certificate and place it in a secure location, because your information is deleted from the site once you have completed the test.
- David Logan mentioned that he noticed in the 2022 FAR/AIM book that the FAA Recognized Identification Areas (FRIA) regulations become effective September 22, 2022. He questioned whether we should be looking into getting our site established as FRIA instead of waiting for guidance from the AMA. Todd

mentioned that we have received no information from the AMA about this requirement and we should wait until we get some guidance, but some due diligence may be advisable.

#### New Business

#### • Warbirds Over Iowa

The event was submitted and received the event sanction by the AMA. It has been submitted as a Show You Care event for publicity, but we have not heard back.

#### • Leader Club

David Logan is working with the AMA to get our Silver Leader Club Status renewed for 2023.

#### • Guest Pilots

A reminder was given regarding having guest pilots at the field. A person <u>must</u> be a member of the AMA to fly at our site. A guest pilot who is not a member of our club must receive permission from one of the club officers prior to flying. Non-members who are trying out flying using a buddy cable with a member pilot is permitted.

#### • New Sanction Rules for AMA Events

The AMA has issued new ceiling requirements for sanctioned events. The AMA allows a 700 foot ceiling for sanctioned events and will permit 1200 feet if requested. The normal ceiling is 400 feet.

#### • Van for Sale

Wendell is trying to sell his Honda van. It is certified to be a good plane hauler. Call him if you are interested in it.

#### • Event Ideas

Gene Thorn suggested we have an ugly plane or a twin engine emphasis day at the airfield. He thought it would be a fun idea to get some different planes and pilots out to fly planes we don't normally see. Discussion followed but no motion or decisions were made.

#### • Airspace Updates

The airspace for model aircraft is still under attack. Corporations are trying to get control of what uncontrolled airspace remains for drone delivery and other such uses. The AMA is doing a good job fighting against this. We should be aware of this because it may come to affect our ability to fly in the future. Also, it was mentioned that there are environmental impact studies being conducted on some sites that have requested FRIA

status. In addition, transponder studies have been conducted on model aircraft and there has been instances where transponder usage caused interference at controlled airports.

#### • Landscape on the Infield

The trees in the infield are starting to get large and need to be removed.

#### Show and Tell

Jim Buttleman and Jerry Mattson brought in items for show-n-tell. Pictures will be posted in next month's logbook because they were unavailable for publication at the time the minutes were written.

Jim brought his B-2 Stealth Bomber to show the progress he has made. He still needs to add wingtips. He is painting it slate grey. He 3-D printed the servo hatch covers. He also installed a gyro and wiring for strobes and wingtip lights.

Jerry brought in his Radio Master TX16S. This radio has open source programming and he discussed the fun he has had with his experience as an electrical engineer trying to learn to program the radio. It has a touch screen and seems to be a very robust platform for programming mixes and flight modes.

The meeting was adjourned at 7:51 p.m.
